## **COMPETITION RULES AND REGULATIONS**

### **1. TEAM COMPOSITION AND ELIGIBILITY**

- Each Participating Team can comprise of 2 or 3 students pursuing Law which includes 3 year Course, 5 year Course or PG Course.
- One of the Team member shall be designated as a Researcher.
- In case of a 2 Member team, the Researcher is allowed to present as a Speaker. This is not compulsory, and thus there can be only 1 Speaker in a team.
- Team Members may belong to a Similar College/Institution/University or may be of different College/Institution/ Universities. There lies no restriction to the same.
- A maximum of 3 Teams can participate from a Single University/College, on a first come basis.
- The Official Language of the Competition shall be English.

### **2. REGISTRATION PROCEDURE**

- Teams are supposed to complete their Registration by 30<sup>th</sup> April, 2020. Early Bird Registrations are open until 20<sup>th</sup> April, 2020.
- The Registration Fee for Early Bird Registrations is Rs. 1400. Post early bird registrations, the fee is Rs. 1850. Registrations can be done here – [www.thelawlearners.com/nomcc-2020](http://www.thelawlearners.com/nomcc-2020)
